### Terms and Conditions:

**EXTENDED CARE:** (When in-person) We offer extended care with notice. Weekly before care starting from 7:30am to 8:15am and after care starting at 3:45pm until 5:30pm with advance notice. Fees apply.

**LATE FEES:** Payments are late if not received on or before the above due dates or upon enrollment date. There will be a \$50 late fee plus \$20 per day until paid in full.

**INVOICING:** Invoices will be emailed upon receipt of contract. Extended care charges can be invoiced in advance or the week after they are incurred. Payment can be made electronically. Instructions will be included with invoice for electronic payment. **HANDBOOK:** Other terms and conditions apply as stated in the handbook. Parents are expected to read and sign the handbook within 5 days of enrollment.

**ADDITIONAL SERVICES AS NEEDED:** All newly enrolled students are subject to an additional fee of \$400 for two additional coaching and/or counseling sessions, assessments in all subjects to establish appropriate class placement, and additional behavioral and academic monitoring. Some students may require additional academic or behavioral supports following the initial period. This will be agreed upon with parents and administration and reassessed on a regular basis of not less than once a month.
